It's been 29 years since Pennsylvania's EMS Act, Act 45, was originally signed into law. With the stroke of his pen on August 18, 2009, Governor Edward Rendell signed Pennsylvania's new EMS Act, Act 37. The signing was witnessed by regional EMS providers from throughout the Commonwealth. Three representatives from EMMCO West, including myself, witnessed the signing. It was a great day in Pennsylvania and it promises to have more great days ahead!

Why the optimistic viewpoint? Until the signing of Act 37, PA's EMS system had been handcuffed to a host albatrosses contained within Act 45. Act 37 breathes new life into the Pa's EMS system. Another reason to be optimistic is the opportunity to have your voices and opinions heard by the developers of the new rules

and regulations for Act 37. Just as the new EMS act was formed through a consensus approach, so too will it rules and regulations. And we have just found out that at EMMCO West's Symposium 2010, in April 2010, there will be a town hall meeting with Bureau of EMS Director Joseph Schmitter ! This will be one of the first statewide town hall meetings to discuss proposed rules and regulations for Act 37.

Many of the anticipated components of the Act 37 require rules and regulations to be written. These include the new EMS agency licensing process, medical command and education institute accreditation, and the new levels of certification. All EMS providers will be permanently certified, including EVOC operators. There will be a biennial or triennial registration process

for certified EMS providers, as defined by the rules and regulations.

Meanwhile, some components of Act 37 go into effect immediately or on February 1, 2010. Most of these components are administrative in nature. Of note is the revised state EMS certification examination process. Attempts to take either the practical and written certification examinations now have restrictions as to the number of attempts before remediation or retaking the entire course occurs. Also, sanctions against EMS providers and/or EMS agencies, who are repeatedly out of compliance with the EMS Act, take effect February 1, 2010.

The most anticipated portion of Act 37 is the new levels of certification, specifically the Advanced EMT level. Identified within the national

EMS model document, NHTSA's EMS Education Agenda of the Future, the EMT Advanced level enables specific "ALS" level skills to be performed by qualified EMTs. It's likely that PA will closely follow the skills outlined within the National Scope of Practice and National EMS Educational Standards models. Skills such as blood glucose monitoring, IV therapy, limited drug interventions, combi-tube or King Airway skills, AED, plus additional assessments and treatment modalities will likely be identified within PA's Ad-

vanced EMT Scope of Practice. The Advanced EMT level will have a significant impact on the staffing of BLS and ALS EMS Agencies. How the Advanced EMT will be integrated into the EMS system will be largely shaped by the new EMS Act's rules and regulations.

Copies of EMS Act 37 can be downloaded from "Breaking News" on the EMMCO West Internet site, www.emmco.org. As soon as they are available, EMMCO West will post draft copies of the proposed Act 37 rules and regulations (likely to be in early

2010). In October and November 2009, EMMCO West will be conducting a series of Act 37 orientation sessions. Plan to come out to one of these orientation sessions and learn more about PA's new EMS Systems Act, Act 37.

It's great to be in EMS and to be a part in the formation of tomorrow's EMS system, today!

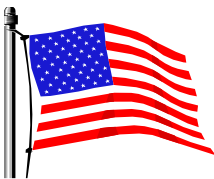

Your Con Ed Corner

As the fall approaches, EMMCO West often sees an increase in continuing education classes. Here are a few points to keep in mind about con ed and your certification.

BLS certifications expire on the first of the month not the end of the month. If your continuing education credit is not completed before the 1st of the month, you will expire! In general, there is no extension or grace period. You will be eligible for the reinstatement process, but will be expired until you can complete that process.

ALS certifications- ALS personnel are required to complete 18 hours of continuing education each calendar year. This requirement is pro-rated for your **first year only** of certification (1.5 hours per month you were certified). Your service medical director is not permitted to waive these requirements.

ALS services may require additional continuing educational require-

ments or impose other time lines for the completion of continuing education.

It is **YOUR** responsibility to ensure that EMMCO West has a copy of your current CPR card on file. While some training officers, con ed sponsors and instructors will submit rosters to our office, it is ultimately your responsibility to ensure we have a copy of your most recent card. Copies of CPR cards that are submitted to our office should contain your certification number, so we can ensure you get credit.

To ensure that you get credit when you take a con ed class bring your certification card or number with you. Con ed sponsors have deadlines to complete paperwork at the end of a class. They have been instructed not to award credit to individuals who do not have their certification numbers with them when they register for the class.

The LMS and the DOH Portals are two different websites. The LMS is free online continuing education. Through the DOH Portal you can check your con ed credit, print status reports, and update your email and mailing address.

LMS classes download each Monday. If you have taken classes on the LMS check the DOH Portal the following Monday to see if your classes are downloading properly. If not give EMMCO West a call so we can resolve the issue.

Con Ed sponsors are required by regulation to provide you with a document stating you completed a con ed session. This is critical for the reinstatement process. Contact the con ed sponsor if you do not receive proper documentation.

Photo ID—Wallet Cards

EMMCO West, Inc. is continuing the processing of photo identification and signatures, as part of the PA Department of Health EMS certification processing. On the new plastic EMS certification identification cards, you can have your photo and signature electronically captured and imprinted onto your certification card.

- Stop in the EMMCO West office (Meadeville, PA), M – F between 8:00 AM – 4:30 PM
- No appointments are necessary
- Bring the following verification items with you:
 - (1) Form of Photo ID (i.e. Drivers License, Passport, or School ID.)
 - Current PA DOH EMS Certification (First Responder, EMT, Paramedic, PHRN)
 - Current CPR certification

Please note, if your certification expires 6 months or less at the time of your photo being taken, we will upload your photo and signature onto the PA Department of Health EMS Registry system. Upon completion of recertification as an EMS Practitioner a new plastic certification card will be issued with your photo and signature imprinted on it.

Missed Calls

EMMCO West's QI committee measures missed calls in order to get a handle on the stress in the system that we are currently not able to handle with existing personnel and resources.

This is not punitive, however there are regulations related to reporting out of service and in the new EMS Act, staffing is 24/7 unless the service is part of an approved county level staffing program.

Your service needs to be aware of this.

Please be honest in the reporting of missed calls, we are interested in all calls to which another service had to respond for a call to which you were on a call and to which you normally would have been dispatched (if you have access to that information).

The reporting form will be changing, there is no

need to submit calls in which there was a delayed response, however your service might be interested in continuing to monitor that.

Missed call reports are due to EMMCO West by the 10th of each month. A separate mailing will be going to all services with a revised form and cover letter.

NEMSIS

Pennsylvania is in the process of transitioning to a national EMS data set (NEMSIS) which can be exported from your PCR program.

If you have not switched over to your vendor's NEMSIS approved version of their software, you need to do so now.

CIA's (QuickTrip) Pennsylvania NEMSIS version is not yet available.

Services will need to upload files via the WebCur uploader unless you have a

program that does not require you to send files to the region (like EMS Charts or EMStat). This requires internet access. If this is impossible, we will need to make other arrangements for transferring the files to EMMCO West securely.

If you have trouble sending files to EMMCO West, perhaps you can find someone in your service or your community who can assist you. Other-

wise, it may make sense to switch to a vendor in which we receive the files automatically. You could also encourage your vendor to come up with a transfer solution which doesn't require a great deal of computer knowledge on your part.

Paper forms are to be used only under extraordinary circumstances.

Warning — Broselow Tape Includes Error

The Institute for Safe Medication Practices warns that Broselow Tape 2007 Edition A contains a dosage error. The Wisconsin EMS office issued an alert in June explaining that this edition (and only this edition), of the tape, which calculates pediatric medication dosages based on the child's weight, states that the glu-

cagon dosage for children weighing 3-4 kg through white zone should be 0.5mg/kg/dose. The *correct* glucagon dosage for children weighing 3-5 kg is 0.5 mg. The erroneous tape also states that for children with weights within the tape's blue through green zones, the dosage should be 1 mg/kg/dose with a maxi-

mum dose of 1 mg. The correct glucagon dosage for children in blue through green zones is 1 mg. The ISMP advises "correcting" 2007 Edition A tapes by using a black pen to block out "/kg/dose." Broselow Tape 2007 Edition B does *not* contain this error.

EMMCO West Critical Incident Stress Management Team

They answer the phone at all hours of the day and night. They drive for hours to get to a service in need. They listen to people tell their stories about the “worst call”, they just responded to. Who are “they”? They are the team members of the EMMCO West Critical Incident Stress Management team. These highly trained team members attend regular training sessions at EMMCO West office and at specialty

training courses recognized by International Critical Incident Stress Foundation.

The EMMCO West Critical Incident Stress Management (C.I.S.M.) Team is a free resource available for all Dispatch, EMS, Fire, and Police personnel. The team can be activated 24/7, 365 days a year by calling (814) 337-5380. In the event of activation, only certified team members will be dispatched by the team coordi-

nator. All interventions are private and confidential.
